More specifically, we will take into account 1) the nature of the processed personal data; 2) the status of the project to which an opposition or hearing statement was submitted; 3) the necessity of the data for operational or development purposes; and 4) the legal periods of limitation which oblige Eurowind Energy to store and delete certain personal data within determined timeframes.</p> <p>The assessment is therefore an individual matter based on e.g. when the project hearings ended, when any opportunity to appeal has expired, or when the project has been approved or completed.</p>	<p>Generally, your personal data is not shared with any third party.
